



Lucky Pets – Transportation Contract and Legal Considerations **LC**

For the purposes of this document, the terms Client, Owner, Pet Owner, and Customer are synonymous with the person contracting services for one or more domestic animals.

- 🐾 A **signed Service Contract** must be provided to your pet transporter before service is provided.
- 🐾 All pets must be at least 8 weeks to be transported. Signing this contract you certify that all pets are at least 8 weeks on or before the pick-up date.
- 🐾 Payment of deposit is due at the time of scheduling. Remainder due at time of pick-up or delivery. All clients using PayPal must submit payments prior to pick-up.
- 🐾 Cancellation – All deposits are not refundable.
- 🐾 A **valid** health certificate issued by a doctor of veterinarian medicine is required, and must be less than 10 days old upon scheduled delivery of pet. Certificate must travel with pet at all times. Medical records or vaccine records cannot be used as a substitution. If transporting multiple pets, each pet must have their own certificate. *Lucky Pets* must be informed of all medical conditions or needs.
- 🐾 All pets 16 weeks and older must have a current rabies vaccination certificate. The certificate must travel with the pet at all times.
- 🐾 All Vet Release Forms must be completed prior to pick-up and available for the pet transporter.
- 🐾 Pet Owner must have legal rights to place the animals in the care of the Pet Transporter.
- 🐾 *Lucky Pets* is authorized to seek any emergency veterinarian assistance needed during transportation, at the cost of the client, from any veterinarian as chosen by the transporter. However, the company is not responsible for the health/well being of the animal while in the care of the veterinarian.
- 🐾 Pet Owner is responsible for supplying enough food for the duration of the transport, plus two days, in a sealed/labeled container, well-fit harness (halter, collar, etc...), and firmly affixed vaccination tags.
- 🐾 Pet Owner will be responsible for all medical expenses and damages resulting from an injury to a Pet Transporter, other pets, or persons, by the Pet. Customer agrees to indemnify, hold harmless, and defend *Lucky Pets*, in the event of a claim by any person injured by the Pet.
- 🐾 Pet Owner is responsible for any and all property damage caused by pet.
- 🐾 *Lucky Pets* makes every effort to pick-up and deliver each pet at their specified time and date. However, we are not responsible for delays due to circumstances beyond our control; such as, weather, road conditions, acts of God, etc.
- 🐾 This contract permits *Lucky Pets* to accept all future telephone, online, mail or email reservations and provide service without additional signed legal considerations agreements.
- 🐾 This agreement is valid from the date signed, and replaces any prior Legal Considerations agreements. Client agrees to any future *Lucky Pets* term changes relayed verbally to the client, mailed or emailed in writing to the client, or posted on our website under the heading Terms.
- 🐾 The owner states that he/she has read this agreement in its entirety and fully understands and accepts its terms and conditions.
